WHEREAS, a public hearing on the 2023 Fire District budget has been held on January 21, 2023 as publicly advertised;


WHEREAS, the Board desires to amend certain line items in the 2023 Budget.

EXPLANATION OF CHANGES

ANTICIPATED REVENUES:

The amount of Amount to be Raised by Taxation to Support Budget, went from \$1,681,617.94 to \$1,753,617.94. In doing so, the 2023 budget will not go over the 2% cap levy, and will balance the 2023 Budget for the anticipated increase in Professional Fees.
