RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS, FIRE DISTRICT # 6,
OF THE TOWNSHIP OF GLOUCESTER, CAMDEN COUNTY, NEW JERSEY, AUTHORIZING
THE PURCHASE OF ONE COMMAND FIRE EMERGENCY VEHICLE
NOT TO EXCEED \$86,000.00, PURSUANT TO N.J.S.A. 40A:14-84

WHEREAS. N.J.S.A. 40A:14-84, of the Laws of the State of New Jersey authorizes the Board of Fire Commissioners to appropriate funds for the purchase of fire emergency vehicle related to fire prevention, the amount to be included in the next annual budget of the Fire District under the section for capital appropriations, and

WHEREAS. The Board of Fire Commissioners, Fire District # 6 of the Township of Gloucester has determined the purchase of one *command* fire emergency vehicle is in the best interest of Fire District #6, and

WHEREAS. The Board determined that the amount to be expended shall not exceed \$86,000.00, which sum shall be approved as part of the Fire District 2026 annual budget, and

NOW THEREFORE , it is herein Resolved that the Board of Fire Commissioners, Fire District # 6 of the Township of Gloucester is hereby authorized to purchase one *command* fire emergency vehicle for an amount not to exceed \$86,000.00, which sum shall be included in the next annual budget of the Fire District under the section for capital appropriations.

BE IT FURTHER RESOLVED by the Board of Fire Commissioners as follows;

- a. That the above resolution shall be approved by the Board of Fire Commissioners at the special public meeting of the Board to be held on December 10, 2025, at the Fire District Office, 1946 Williamstown Road, Erial, New Jersey 08081 between 6 PM and 9 PM.
- b. That all interested parties shall be given an opportunity to be heard at the special meeting on the issue of the purchase one utility body/pickup emergency Vehicle.
- c. That a copy of this resolution shall be published once in a newspaper circulating in the Fire District not later than 10 days prior to the special meeting of the Board of Fire Commissioners to be held at 1946 Williamstown Road, Erial , New Jersey 08081
- d. That a copy of this resolution shall be posted at five (5) public places in the Fire District.
- e. That copies of the resolution shall be available to members of the general public by request to the Secretary of the Board of Fire Commissioners _____.
